## **FIRST 5 CALIFORNIA LEVELS OF PRIORITY BILLS**

Level 1	Sponsor Bills: Align with First 5 California's Young Children Policy Agendas, Mission Statement, North Star, and Audacious Goal. Draft language/amendments; organize partners/meetings; provide testimony/presentations; participate in outreach for support; submit letters/statements of support
Level 2	Priority Bills: Align with First 5 California's Young Children Policy Agendas, Mission Statement, North Star, and Audacious Goal. Provide support; submit letters/statements of support
Level 3	Bills expressly consistent with First 5 California's Young Children Policy Agendas, Mission Statement, North Star, and Audacious Goal: Submit letters/statements of support
